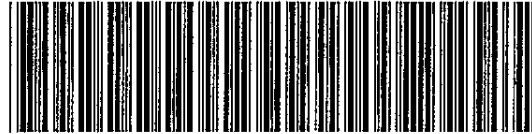

ARTICLES OF INCORPORATION  
OF  
Universal Market of Collier County, Inc.

The undersigned herewith form a Corporation within the Laws of the State of Florida, by and under the provisions of the State Statute providing for the formation, privileges rights, liabilities and immunity of a Corporation.

ARTICLE I

The name of this Corporation shall be:  
Universal Market of Collier County, Inc.

ARTICLE II

The Corporation will operate an independent grocery business and may engage in any legal business activity permitted under the laws of the United States and the State of Florida.

ARTICLE III

The amount of Capital Stock authorized shall be 1000 Shares of common stock with a par value of \$10.00 per share. Said stock shall be non-assessable, to be held, sold and paid at such time and in such manner as the Board of Directors may determine.


The Incorporator shall hold office as the Director of the Corporation until a successor shall be elected or appointed, at which time the Incorporator shall resign.




