



ARTICLES OF INCORPORATION

OF

DR. BUTTLER'S REMEDIES, INC.



ARTICLE I

<u>NAME</u>

The name of the corporation shall be: DR. BUTTLER'S REMEDIES, INC.

ARTICLE II

GENERAL NATURE OF BUSINESS

This corporation is hereby authorized to carry on and to license and authorize others to carry on any legal business in any other state as well as the State of Florida.

ARTICLE III

CAPITAL STOCK
