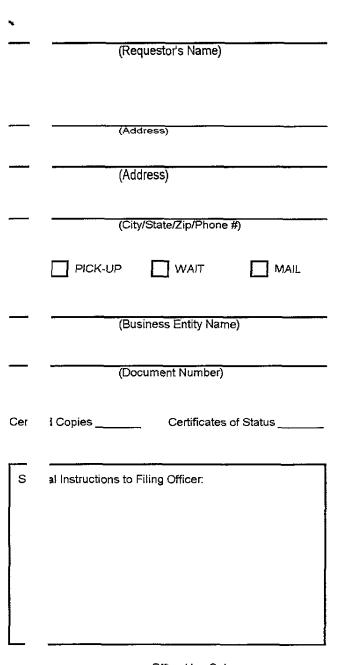

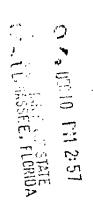
Article V
