

## ARTICLES OF INCORPORATION OF DISTINCTIVE HOUSE PLANS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE 1: NAME

The name of the corporation shall be:

DISTINCTIVE HOUSE PLANS, INC.

ARTICLE 2: EFFECTIVE DATE

The effective date of the corporation shall be January 1, 2005

ARTICLE 3: ADDRESS

#### ARTICLE 4: NATURE OF BUSINESS AND POWERS
