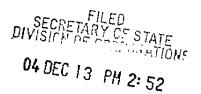

ARTICLES OF INCORPORATION



ARTICLE I, NAME

The name of this Corporation shall be: ZIGO ENTERPRISES, INC.



ARTICLE IL PRINCIPAL OFFICE

ARTICLE III. COMMENCEMENT & DURATION
