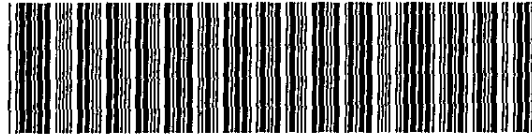

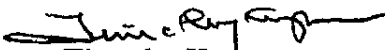

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the Corporation ("Corporation") is A Special Finish, Inc..

ARTICLE II - DATE

The existence of the Corporation shall begin on 10 December 2004.

ARTICLE III - ADDRESS
