ARTICLE I

ARTICLE V

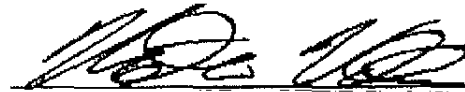

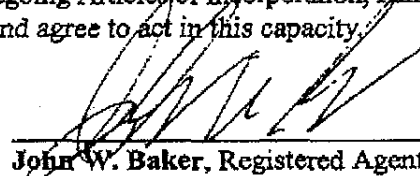
