ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business

Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of

Article 1. Name. The name of the Corporation is:

Article 2. Mailing Address. The mailing address of the Corporation is:

Article 3. Officers. Justin Cashmore will be President, Secretary and Treasurer of the Corporation.

Article 4. Duration. The duration of the Corporation is perpetual.

In the event these Articles of Incorporation are not filed within the time period set forth in Section 607.0203, Florida Statutes, the date when corporate existence shall commence is the date of filing by the Secretary of State.
