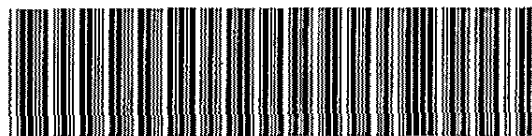

ARTICLES OF INCORPORATION

OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE

The name of the Corporation ("Corporation") is **Crawford Home Services, Inc.**

ARTICLE II

The street address of the principal office of the Corporation is **175 Shady Lane, Oviedo, FL 32765**

The purpose for which this corporation is organized is any and all lawful business.


ARTICLE VIII
