ARTICLES OF INCORPORATION OF THET-SA CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I (Name and Mailing Address)

The name of the corporation is THELSA CORPORATION, and its mailing address is 3341 Pointe Creek Court, Unit 106, Bonita Springs, FL 34134.

ARTICLE II (Duration)

The duration of this corporation is perpetual and its existence shall commence on the date of execution and acknowledgment of these Articles.

ARTICLE III (Purpose)

The general purposes for which this corporation is organized are to engage in the business of investing in real property, the construction improvements thereon, to manage, lease, sell and otherwise deal in real property for investments and profit; to engage in such other activities as are incidental to or connected with the operation of such business; and to transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.


