**ARTICLES OF INCORPORATION  
OF  
J & D's FLAPPERS II, INC.**

The undersigned, who, if a natural person, is eighteen years of age or older, hereby establishes a corporation pursuant to the Florida Business Corporation Act, as amended, and adopts the following Articles of Incorporation:

**Article I.  
Corporate Name**

The name of this corporation is J & D's Flappers II, Inc.

**Article II.  
Duration**

The corporation shall have an effective date of January 1, 2005, and shall exist perpetually.

**Article III.  
Purpose**
