ATRICLES OF INCORPORATION OF MEDSPA ONE, INC.



ARTICLE I - NAME

The name of this corporation is Medspa One, Inc.

ARTICLE II - DURATION

As provided in Chapter 607 of the Florida Statutes, this corporation shall exist in perpetuity.


