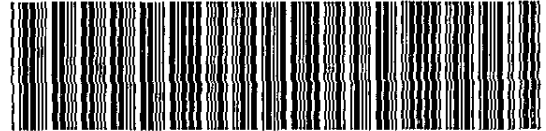

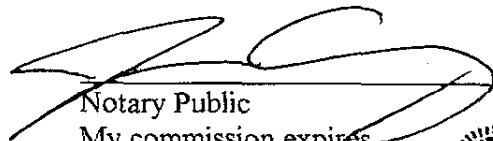
Article VII - Amendment

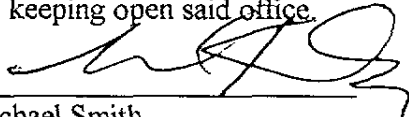

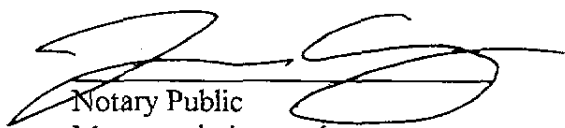
