ARTICLES OF INCORPORATION

OF

INDIVIDUAL & FAMILY COUNSELING SERVICES, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE Name

The name of the corporation is: INDIVIDUAL & FAMILY COUNSELING SERVICES, INC.

ARTICLE TWO **Principal Office**

The street address of the initial principal office of the corporation is 303 E. 7th Street, Panama City, FL 32401.

ARTICLE THREE **Corporate Duration**

The duration of the corporation is perpetual.
