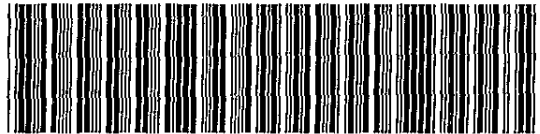

ARTICLES OF INCORPORATION
FOR
CEDAR CREEK REALTY, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name, Location and
Mailing Address of Principal Office

The name of the corporation is CEDAR CREEK REALTY, INC. The principal office and mailing address of this corporation is 4763 Fremont Street, Jacksonville, Florida 32210.

ARTICLE II

Purpose

This corporation is organized for to engage in the business of sales, marketing, management and leasing of real property, and to transact any and all other lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

This corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in Section 1361(c)(2)(or its successor section) of the Internal Revenue Code. In addition, no stock shall be issued or transferred to a nonresident alien. The corporation is authorized to issue five hundred (500) shares of capital stock, of which all five hundred (500) shares shall be issued to Brian Parker, each share having a par value of \$1.00.

ARTICLE IV

Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 4763 Fremont Street, Jacksonville, Florida 32210, and the name of the initial registered agent of the corporation at that address is Brian Parker.

The Board of Directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.



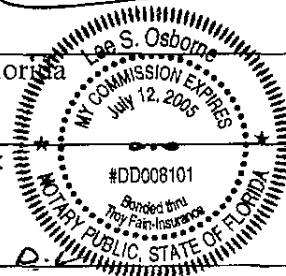


