ARTICLES OF INCORPORATION

OF

WESCAR MAGNOLIA, INC.

The undersigned, being of legal age and desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act"), executes the following Articles of Incorporation.

ARTICLE I

The name of the corporation is WESCAR MAGNOLIA, INC.

ARTICLE II Commencement of Corporate Existence

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall have perpetual duration unless sooner dissolved according to law.

ARTICLE III Purpose and General Powers

The Common Stock shall possess and exercise exclusive voting rights and at all meetings of the shareholders each record holder of such stock shall be entitled to one vote for each share held. Shareholders holding Common Stock shall have no cumulative voting rights in any election of directors of the Corporation.

C. No Preemptive Rights

No holder of shares of any class of the capital stock of the Corporation shall have as a matter of right any preemptive or preferential right to subscribe for, purchase, receive, or otherwise acquire any part of any new or additional issue of stock of any class, whether now or hereafter authorized, or any bonds, debentures, notes, or other securities of the Corporation, whether or not convertible into shares of stock of the Corporation.

ARTICLE V Initial Registered Office and Agent: Principal Place of Business

The initial registered office of this Corporation shall be located at the City of Mount Dora, County of Lake and State of Florida, and its address there shall be, at present, 1033 Augustus Lane, Mount Dota, Florida 32757, and the initial registered agent of the Corporation at that address shall be Louis Geys. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation. ARTICLE VI Initial Board of Directors
