ARTICLES OF INCORPORATION OF AGILITY SERVICE ENTERPRISING, INC.

The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows:

ARTICLE I

NAME

<u>ARTICLE II</u>

PURPOSE

The general nature of the business to be transacted by this corporation shall be:

- 1. Home repairs, real estate purchasing, renovation and import-export of general merchandise.
- B) To purchase, exchange, hire, or otherwise acquire such personal property, chattels, rights, easements, permits, privileges and franchises as may lawfully be purchased, exchanged, hired, or acquired.

- E) To borrow money with or without pledge of or mortgage on all or any of its property real or personal, as security and to loan and advance money upon mortgages on personal or real property or on either of thera.

P) To buy, sell, and deal in, with or without guarantee of payment thereof, bonds and mortgages and other like securities and other kinds of property, whether real or personal, not prohibited or specifically excepted by law, and to do and prosecute any facts or things incidents to or proper in connection with the carrying on of the business of the corporation.

G) To purchase, acquire, hold, sell, assign, transfer, mortgage, pledge, and otherwise dispose of the shares of capital stock, bonds, debentures, or other evidence of indebtedness of any corporation, domestic or foreign, and while the holder thereof, to exercise all the rights and privileges of ownership, including the right to vote thereon, and to issue in exchange therefore its own stock, bonds, and other obligation:
