**ARTICLE I - NAME**

The name of this corporation is HIDDEN RESOURCE GROUP, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of filing these Articles of Incorporation with the Department of State of the State of Florida.

**ARTICLE III - PURPOSE**

The general nature of the business shall be any and all business allowed by law.

**ARTICLE IV - CAPITAL STOCK**

(a) The capital stock of the corporation shall be divided into 1,000 shares of common stock with par value of \$.01 per share, and each share shall entitle the holder thereof to vote at any meeting of the shareholders.

(b) The consideration to be paid for each share shall be payable in lawful money of the United States of America, or in property, labor, labor or services at a valuation to be fixed by the incorporator or by the Board of Directors at a meeting called for such purpose.

(c) Shares of the Corporation's stock and certificates therefor shall be issued only in accordance with these Articles of Incorporation and the Bylaws of the Corporation.

(d) All shares of stock shall be Common Stock of the same class.

(e) All stock, when issued, shall be fully paid for and shall be non-assessable.


ARTICLE X - POWERS






