**ARTICLES OF INCORPORATION
OF
TCR INTERNATIONAL USA, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is TCR International USA, Inc.

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**


