

ARTICLES OF INCORPORATION

FOR

DOMENICO ARDITO, P.A.

The undersigned, acting as incorporator for this business corporation pursuant to Chapter 621 of the Florida Statutes, hereby form a Professional Services Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be **DOMENICO ARDITO, P.A.**

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 16 day of December, 2004, and shall exist perpetually.

ARTICLE III
GENERAL PURPOSE


ARTICLE VII
