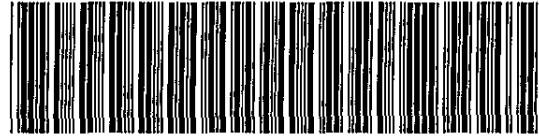

The undersigned hereby establishes the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

**ARTICLE I**

**Name of Corporation**

The name of this Corporation shall be FINANCIAL INSIGHTS AND SOLUTIONS, INC. (the "Corporation").

**ARTICLE II**

**Mailing Address**

The mailing address of the Corporation is 625 North Flagler Drive, Suite 508, West Palm Beach, Florida 33401.

**ARTICLE III**

**Purpose**

This Corporation is organized for the following purposes:

- (a) To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which the Corporation is organized and any and all acts amendatory thereof and supplemental thereto.

### Indemnification

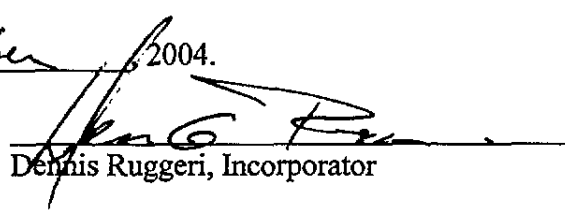
The Corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

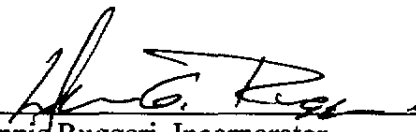
