IN WITNESS WHEREOF, the undersigned President of this Corporation executed these Articles of Amendment this 30<sup>th</sup> day of April, 2012.

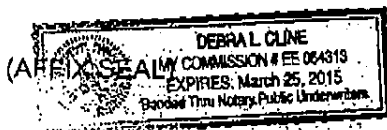


