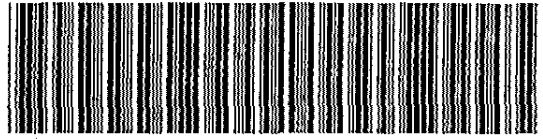

**CONSENT TO USE NAME**

**THIS CONSENT TO USE** is made as of this 3rd of December 2004, by and between GT Grandstands, Inc., a Florida Incorporation and GT Grandstands of Florida, Inc., a proposed Florida Incorporation.

**WHEREAS** Tom Ennis has registered and is using the words GT Grandstands, Inc. as its legal name in the State of Florida and elsewhere throughout the United States (hereinafter referred to as the "Licensed Name"); and

**WHEREAS**, GT Grandstands of Florida, Inc. is desirous of using said Licensed Name in the State of Florida (hereinafter referred to as the "Territory");

**NOW, THEREFORE**, in consideration of the mutual covenants of the parties and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. **License.** GT Grandstands, Inc. grants to GT Grandstands of Florida, Inc. the right under common law to use the Licensed Name in the Territory.

2. **Extent of License.** The right granted in Paragraph 1 hereof shall be exclusive and shall not be transferable without GT Grandstands, Inc. prior written consent. The license herein granted shall not be assignable or transferable in any manner whatsoever, nor shall GT Grandstands of Florida, Inc. have the right to grant sublicenses, except by prior written consent of GT Grandstands, Inc.

3. **Termination.** This Agreement shall remain in full force and effect in perpetuity and is not terminable.

4. **Notices** Any notices required or permitted to be given under this Agreement shall be deemed sufficiently given if mailed by registered mail, postage prepaid, addressed to the party to be notified at its address shown below, or at such other address as may be furnished in writing to the notifying party.
