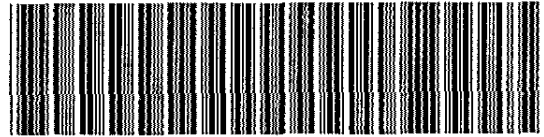

**ARTICLES OF INCORPORATION
OF
J. P. Safety Training, Inc.**

I, **Jose R. Pompa** the undersigned, hereby organize for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida, providing for the formation, rights, privileges, immunities and liabilities of Corporation for profit.

ARTICLE I – NAME

The name of the Corporation shall be:

J. P. Safety Training, Inc.

ARTICLE II – DURATION

This Corporation shall exist perpetually, commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III – PURPOSE

The Corporation may engage in any activity of business under the laws of the United States and the State of Florida General Corporation Act.

ARTICLE IV – CAPITAL STOCK

This Corporation is authorized to issue 100 shares of \$1.00 par value common stock, which should be designated "Common Shares".

ARTICLE V – CAPITAL

The amount of capital with which the Corporation will begin business shall be \$100.00.

ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII

This Corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by a majority vote of the stockholders, but it shall never be less than one.

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.

ARTICLE XI – RESTRICTIONS ON TRANSFER OF STOCK

Shares of capital stock of this Corporation shall be issued initially to the following persons in the amount set opposite their names:

Shares held by the initial shareholders listed above may not be re-sold or otherwise transferred to other persons unless such share are first offered to the remaining shareholders or to this Corporation. The price and terms at which, and the time within which, such shares may be offered and sold shall be further specified by written agreement among all of the shareholders and this Corporation.

ARTICLE XII – ADOPTION OF BYLAWS

A special meeting of the subscriber or his assigns shall be held, upon the call of the president, for the purpose of completing the organizations of the Corporation and the adoption of the bylaws and the transaction of such other business as may come before the meeting.


ARTICLE XIII – AMENDMENT




