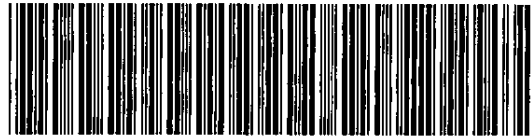

This amendment is submitted to amend the following:


Article IV shall be amended to read as follows:
