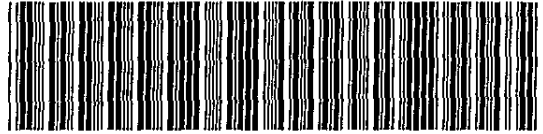


ARTICLE IX

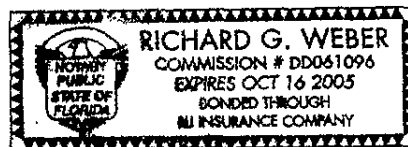
