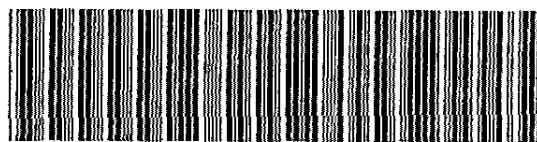

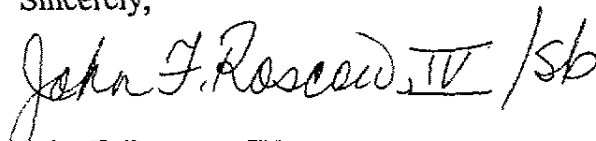

OF

The undersigned, acting as Incorporator for this Florida corporation hereby incorporated under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, and the undersigned hereby adopts the following Articles of Incorporation for this Corporation:

**ARTICLE I - CORPORATE NAME & ADDRESS**

The name of this Corporation is J.S. PHOTO & VIDEO, INC., and the mailing address for the principal office of this corporation is 6032 N.W. 31<sup>st</sup> Terrace, Gainesville, Florida, 32653. The telephone number is (352) 372-4462.

**ARTICLE II - PURPOSE**
