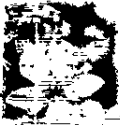

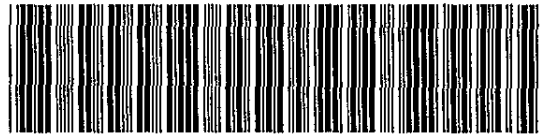

ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is **DEBORAH A. BELFORD, P.A.**

**ARTICLE II**

**DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III**

**PURPOSE**

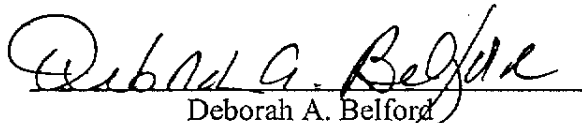
**ARTICLE VIII**
