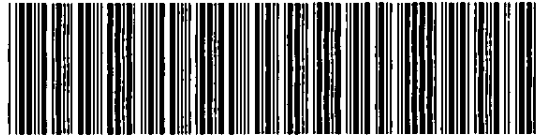


WHEREAS, the Company's sole director desires to file Articles of Amendment to change the name of the Company to Care Media Holdings Corp. which amendment requires shareholder approval
