Per telephone conversation with your office today they requested we send you this letter and copies of certain documents along with the Corporation Reinstatement Form


We believe that since the company had responded to your first request and followed through with the proper filings and fees paid on a timely basis that their company should be reinstated immediately with no additional fees.
