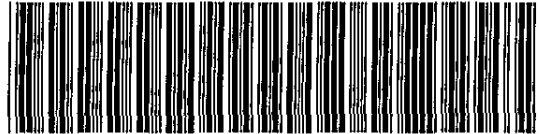

ARTICLE I

NAME

The name of the corporation is **NORTHBROOKE BUILDING INSPECTIONS, INC.**

ARTICLE II

DURATION

The duration of the corporation is perpetual.
