### ARTICLES OF INCORPORATION HARVEY L. KANSOL, D.D.S., P.A.

#### ARTICLE III

#### <u>PURPOSE</u>

The purpose or purposes for which the corporation is formed are:

- (a) To engage in every aspect of the practice of dentistry in the State of Florida through persons qualified to practice dentistry in the State of Florida.
- (b) To own and operate an office or offices, including electrical and mechanical equipment, supplies and materials, and all other facilities necessary or used in or incidental to the operation of such practice.
- (c) To engage generally in the business of a dental corporation, or in any business in connection with the foregoing services and incident thereto, not forbidden by the laws of the State of Florida.
