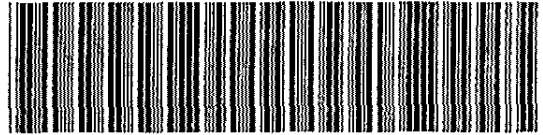

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is SRQ COMMERCIAL MANAGEMENT, INC.

ARTICLE TWO

The period of its duration is perpetual.
