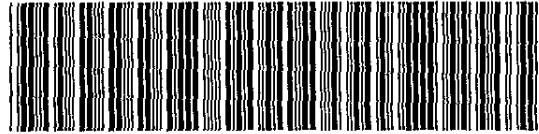

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is A & O RIVERA TILE, INC.


