5. VISICH OF BUH 2: 35

The undersigned, being qualified to act as incorporators under the Florida General Corporation Act, adopt the following Articles of Incorporation for the purpose of organizing a Corporation under the Act:

1. The name of the Corporation is:

SOULFUN, INC.

- 2. The duration of the Corporation is perpetual.
- 3. The street address of the registered office and the principal office of the Corporation in the State of Florida shall be 9018 Iron Oak Avenue, Tampa, Florida 33647, and the name of the Registered Agent at such address is BRIAN T. JORDAN.
 - 4. The Corporation is to be for profit.
- 5. The purposes for which the Corporation is organized are:

To own, operate, manage and invest in one or more franchises or other businesses;
