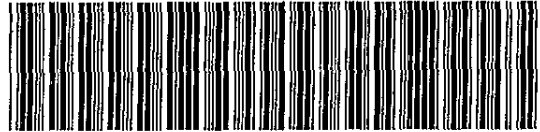

The undersigned, acting as the incorporator of Prince Resort 2, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is: Prince Resort 2, Inc.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence at the time and on the date these Articles of Incorporation are filed with the Florida Department of State.

ARTICLE III. PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE IV. INITIAL BOARD OF DIRECTORS
