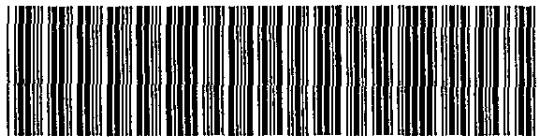



**ARTICLES OF INCORPORATION
OF
ANCIENT RITUAL TATTOO, INC.**

ARTICLE I: CORPORATE NAME

The name of the corporation is: **ANCIENT RITUAL TATTOO, INC.**

ARTICLE II: The general purposes for which the corporation is organized are:

1. To engage in the general business of body tattooing and any lawful activity related thereto;

ARTICLE VII: BOARD OF DIRECTORS


