I have ordered this form by phone, as I have no access to internet, and no transportation to get to the library. I know there is a fee for being late. I just can't afford to send you all the money immediately. As directed by the woman who answered the phone, I am asking that you waive the late fee, as this is my first year in business ever, and this extra \$400 is going to be one of the many make it or break it points this year. I haven't even made enough money to put up a sign yet. The tattoo business is a word of mouth business, and I have been building my cliental in this manner. As of lately, it has been particularly slow. This happens if it is too hot, too cold, or even perfect beach weather. It is unpredictable. I know I can make this business work, I just need some time. I ask you, Madam Secretary please to forgive the lateness of this document and payment, as it would be a great help in keeping the doors open.

I am the president, founder, and only employee of Ancient Ritual Tattoo, Inc., and it has been difficult doing all that is necessary on my own. I had to remove carpet and install a ceramic tile floor for sanitary reasons. There was a drywall divider that needed to be installed to keep the customer area and the biohazard containers separate. I had to install a separate stainless steel sink for washing tubes and provide storage areas for sterile equipment, not to mention the cost of the autoclave, and its testing procedures. This has been very difficult for me since only last year all of my equipment and car were stolen from me in Orlando. I am currently working with someone in the Sherriff's department to rectify this situation, but am afraid I will not see that property again. In the meantime, I walk to work, and spend the rest of my time helping a handicapped friend of mine with daily and work related issues. Enclosed is a bio about her, and a couple of prayer cards that she had printed from paintings she did with her mouth.

I look forward to building my business up to be a productive citizen of this state, and helping Connie to launch her efforts with Art For Mobility. I just need a little bit of help to hurdle this first year of business, and I promise to be on time next year.
