ARTICLES OF INCORPORATION

OF MATA CONCRETE AND CONSTRUCTION

SECRETARIO STORESTATORS The undersigned incorporator hereby certifies to the following in order to form a corporation for a profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is, MATA CONCRETE AND CONSTRUCTION, INC.
