The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

#### **ARTICLE I - NAME**

The name of the corporation ("Corporation") is: Ringling Cleaners, Inc.

# **ARTICLE III - PURPOSES**
