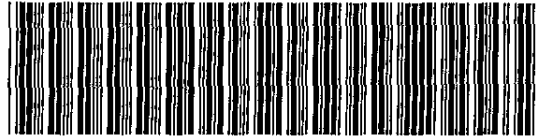

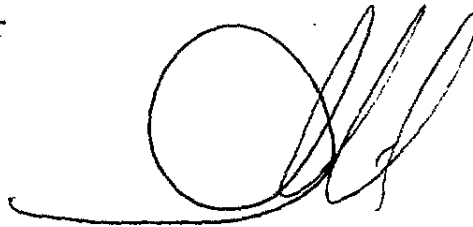
ARTICLE 7- DIRECTORS-INCORPORATOR
