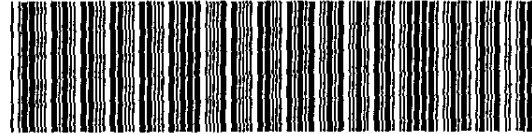

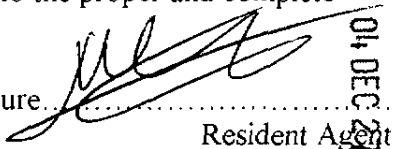

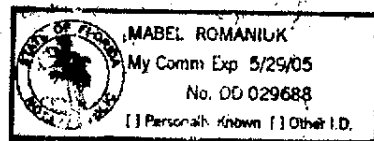
ARTICLE X - AMENDMENT
