

**THE UNDERSIGNED**, acting as sole incorporator of G.H. MARKETING, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

The name of the corporation shall be G.H. MARKETING, INC.

**Shares**
