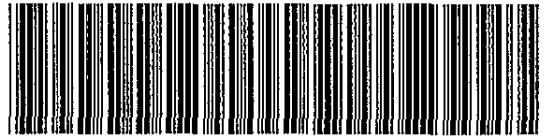



The undersigned, desiring to form a corporation in compliance with Chapter 607 and/or Chapter 621 of Florida Statutes, certify that:

Article I – Name.




