The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is FLORIDIAN BREEZE, INC.

ARTICLE II NATURE OF BUSINESS
