ARTICLES OF INCORPORATION

OF

BEN BASHTON CARPENTRY, INC.

I. THE UNDERSIGNED, BEING OF FULL AGE, DO HEREBY SUBSCRIBE FOR THE PURPOSES OF FORMING AND ORGANIZING A CORPORATION FOR PROFIT UNDER THE CORPORATION LAWS OF THE STATE OF FLORIDA. AND HEREBY ADOPT AND DECLARE THE FOLLOWING ARTICLES OF INCORPORATION COVERING THE EXISTENCE AND ORGANIZATION OF THIS CORPORATION:

ARTICLE 1

THE NAME OF THE CORPORATION SHALL BE BEN BASHTON CARPENTRY. INC.

ARTICLE 11

THIS CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES OF AMERICA AND THE STATE OF FLORIDA.

THE MAXIMUM NUMBER OF SHARES OF STOCK AUTHORIZED TO BE ISSUED BY THIS CORPORATION SHALL BE LIMITED TO ONE THOUSAND (1.000) SHARES OF COMMON STOCK OF THE PAR VALUE OF \$ 1.00 PER SHARE. AND EACH SHARE OF COMMON STOCK SHALL ENTITLE THE HOLDER THEREOF TO ONE VOTE AT ANY STOCKHOLDERS' MEETING AND SAID COMMON STOCK SHALL OTHERWISE FULLY PARTICIPATE IN ALL STOCKHOLDERS' MEETINGS AND IN THE ASSETS OF THE CORPORATION, AND SHALL BE FULLY PAID AND NON-ASSESSABLE.
