The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE 1.0 NAME AND ADDRESS**

The name of the Corporation is \$1.99 Dry Clean Superstore, Inc. The principal office and mailing address is 6001 Argyle Forest Blvd., Suite 10, Jacksonville, Florida 32244.

**ARTICLE 2.0 EFFECTIVE DATE AND DURATION**

The Corporation shall become effective January 1, 2005 and its duration shall be perpetual.

**ARTICLE 3.0 PURPOSE**

The general purpose for which the Corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.


**ARTICLE 8.0 AMENDMENT**


