I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I.

The name and initial address of this Corporation shall be: CW Meyers Corporation, 361 West Lake Faith Drive, Maitland, Florida 32751, with the privilege of having its offices and branch offices at other places within or without the State of Florida.
