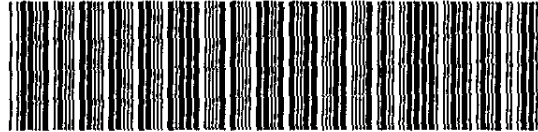

ARTICLE I. CORPORATE NAME:

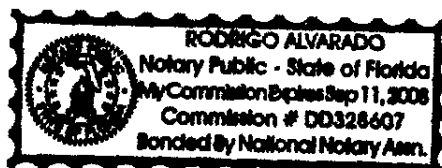
