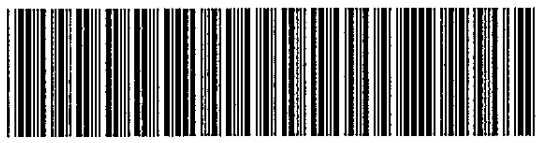



ARTICLE I. NAME

The name of this corporation is

ARTICLE II. DURATION
